## **NOTICE OF PCC-USA 2024 ELECTIONS** **(FOR 2025-2026 TERM OF OFFICE)**

As per Constitution & Bylaws of the PCC-USA, the General Elections are to be held during the month of December every other year. This year the PCC-USA Executive Board of Directors in conjunction with Election Commission has announced that the elections are to be held on 15 December 2024. As first step of the election process, EBD has established a three (3) member Election Commission to conduct these elections. Election Commission (“EC”) members are: Tariq Minhas, Sohail Syed, & Rashid Khokhar.

For the 2024 Elections, the PCC-USA EC2024 announces the following schedule:

Please use the enclosed Nomination Form and submit it to the Chairperson EC along with **appropriate nomination fee**. Best way to submit the Nomination Forms is via email to: [Rkhol@aol.com](mailto:Rkhol@aol.com). For forms submitted via email, EC will then contact the Nominators and/or Nominees to make arrangements for collecting the Nomination Fees. Only money orders or cash will be accepted.

Alternatively, you may mail the forms to: **Rashid Khokhar, PCC-USA EC, 4007 Mt. Vernon Ave, Sugar Land, TX 77479**. Please affix appropriate postage and make sure that the forms get delivered by the stated deadline. If submitting nominations via surface mail, the Nomination Fee **MUST** be included. Via mail, only money orders will be accepted as Nomination Fee.

**Please remember: The responsibility to make sure that nominations are received by EC before the deadline is yours. EC will be willing to meet any PCC-USA member at any reasonable time to receive nomination papers. Please contact EC as soon as possible and make necessary arrangements.**

# PCC-USA Elections of EBD for year 2025-26 term of office

## Notes & Instructions for Nomination Form

PCC-USA EBD office holders are elected every other year for a two (2) year term for the following eleven (11) positions; five (5) Officers and six (6) At Large Directors.

- 1- President
- 2- Vice president
- 3- General Secretary
- 4- Joint Secretary
- 5- Treasurer
- 6- Six (6) At Large DIRECTORS

Pertinent information as well as the qualifications and requirements for various positions are briefly listed below. These are for reference purposes only and by no means are complete or exhaustive. The actual PCC-USA Constitution & Bylaws (“PCC C&B”) shall prevail in all instances arising from any omission or mistake or contradiction in this document.

You may nominate only one (1) individual for any one Officer position. *Nomination and/or seconding of multiple individuals for the same position by the same nominator or same seconding member may render invalid all such nominations.* You may submit nominations for multiple positions for different nominees and make copies of the Nomination Form as needed.

For At Large DIRECTOR positions, any nominator or seconder may do so for up to six (6) individuals on separate forms.

Both the nominator and the person seconding the nomination must be dues paying members of PCC-USA in good standing as per the Voters’ List. You may consult the membership list(s) for status verification purposes by contacting the PCC-USA executives.

For all positions, except as noted below, the nominee must be a due paying non-corporate member of PCC-USA in good standing for at least sixty (60) days as of the Election Day. Additionally, he/she should: 1) be over 18 years of age by election day, 2) must be a citizen or lawful permanent resident of USA, 3) should not be an office holder of any other organization having aims or objectives that are in conflict with those of PCC-USA.

For the positions of President & Vice President, the nominees must also be of Pakistani lineage.

A nomination fee of US \$100.00 for each position, via money order or cash, is required with all nominations.

Eligibility to vote at the general elections will be based on the record date set by EBD which has been declared as 25 October 2024. Any potential voter **MUST** contact the PCC General Secretary or other Executives to resolve membership status before this date.
